Their role is not always easy, so we ask you to present on your stands only products of impeccable quality. Non-compliant or questionable items will be systematically removed.

### **REGULATIONS**

#### **Article No. 1**

The 49th Antique Fair will be held on 06<sup>th</sup>, 07<sup>th</sup> and 08<sup>th</sup> August 2022 on the locations of the halls of the Green Valley complex and the surrounding land.

This regulation has been established by the association «Arts - Antiquities - Leisure» and manages the conditions of registration at this 49th Salon.

#### **Article No. 2**

This event is exclusively reserved for professionals who must provide:

An extract K bis from the trade register of less than 3 months

A double-sided photocopy of the card allowing the exercise of a current commercial activity

A photocopy of the declaration receipt at the Business Formalities Centre (for auto-entrepreneurs)

A photocopy of a prefectural receipt

Artist House Affiliation Number (for art galleries)

1 certificate of company liability insurance

#### **Article No. 3**

Participation in costs:

Indoor location

Room With surface 15.00 m<sup>2</sup> or 5.00 m x 3.00 m

Room B surface 15.00 m<sup>2</sup> or 5.00 m x 3.00 m

Room C surface 15.00 m<sup>2</sup> or 5.00 m x 3.00 m

Location at a cost of 450 Euros

Outdoor location surface 33 m<sup>2</sup> or 6.60 m x 5.00 m (approximately)

Pitch cost 290 Euros

There will be no half stand

#### **Article No. 4**

Bookings inside and outside the rooms will be based on available seating and THEIR ORDER OF ARRIVAL

#### **Article No. 5**

Method of settlement:

50% as a deposit cashable after 1 June 2022

50% as cashable balance after the show

#### **These two cheques must be attached to the application form.**

Any non-compliant or incomplete records will be returned without consideration.

Therefore, only final site requests sent individually and accompanied by the two cheques will be considered.

No registration will be taken into account until the complete file is returned. No request by telephone, fax or e-mail will be taken into account without immediate return of the complete file, online registrations on the website [www. salon-antiquaires.co.uk](http://www.salon-antiquaires.co.uk) will be validated only upon receipt of the cheques.

For any withdrawal of participation before 15 June a package of 50 Euros will be retained on the refund for management fees and sending of files.

After this date the deposit paid will remain acquired to the association or 50% of the registration fee.

Passed 15 July the totality of the amount of the site will be acquired to the association

The Organizing Committee reserves the right to change the locations as the circumstances require, without recourse.

#### **Article No. 6**

In order to preserve the quality character of the event, the exhibitors undertake not to present on their stands: no furniture, trinkets, jewellery, etc. new or copy. Similarly, any furniture or objects whose recent modification would have transformed the original design are prohibited. Exhibitors who do not comply with this obligation will be immediately excluded from the show without compensation, the full amount of their registration remaining acquired to the association. Any display specifying the terms: liquidation, sale at cost, discount, etc. is strictly prohibited. As such, the organizer may at any time request the removal of any object or display if it deems it non-compliant

Experts will be present throughout the show to enforce this clause and will be at your disposal and that of the public (free of charge) for any product evaluation.

#### **Article No. 7**

The reception of the exhibitors and the availability of the sites will be done,

Thursday and Friday from 9 am to 12 pm and from 2.30 pm to 7.30 pm for indoor pitches

Friday from 14:30 to 20:00 for outdoor locations

#### **Article No. 8**

The exhibited objects remain under the responsibility of their owners, at their own risk and peril the association "Arts, Antiquities and Leisure" shall under no circumstances be held personally liable for the property displayed and for the damage suffered by them or by their servants, in particular in the event of theft, loss, breakage or other damage, including fortuitous or force majeure.

Exhibitors will do their own personal insurance business for their coverage.

#### **Article No. 9**

The association "Arts Antiquités et Loisirs" is committed to making a specific advertising promotion effort for the Antique Fair, both through posters, leaflets and press at the regional level.

#### **Article No. 10**

The facilities of the stands must be completed on the opening day at 9:30 am and the transport vehicles evacuated no later than 9:45 am. The exhibitors undertake to be present on their stand for the entire duration of the show.

Arts-Antiquités-Loisirs may automatically and without prior notice dispose of any site and stand which the owner would not have taken possession of in the morning (9:00 am) of the opening to the public. Amounts paid will remain vested in the association

In the rooms the fasteners to the ground and to the walls of the installations are strictly prohibited as well as in the part «bitumen» for the exteriors.

### **Article No. 11**

Opening hours of the show to the public from: 10 am to 7 pm on Saturdays and Sundays and from 10 am to 5 pm on Mondays

Exhibitors will be able to access the stand from 9:00 am or 1:00 am before the opening to the public

Circulation inside the rooms is strictly forbidden after the closure to the public, the site being completely closed 30 minutes later

On the last day of the show, the exhibitors are required to pack up their goods only after the departure of the public, from 17h. Any offender will not be picked up at the next demonstration.

Each exhibitor will be required to dispose of its entire site and not allow any waste, installation or goods to remain. Containers will be placed on the periphery of the show to collect waste.

### **Article No. 12**

The exhibitors undertake to maintain order on the sites placed at their disposal.

In addition, they will have to comply with the regulations on order and safety.

In order to protect the reception of visitors the parking of the vehicles of the exhibitors is strictly prohibited street of the Green Valley and at the back of the rooms (within the living room) parking will be available to exhibitors

The vehicles of the offenders will be removed by the public authorities at the expense of the owners.

It will be issued a button on which must appear: the name of the owner and the number of the stand of the latter.

### **It shall be visible on the windshield of the vehicle.**

Any vehicle in violation of the parking will be liable to be verbalized by the National Gendarmerie without further notice.

**SAFETY:** The circulation within the living room of any vehicle during the opening hours to the public is strictly prohibited. Failure to comply with this clause will result in the outright, simple, immediate and definitive exclusion of the exhibitor without possible recourse

**Security of the lounge:** Barriers of the Heras type are located on the outskirts of the lounge. These barriers can be placed by us for the setting up of your stands. They will be closed 1/4 hour before opening to the public and reopened after closing. Under no circumstances will they be deposited during public hours. The enforcement of these protections will result in the outright, simple and immediate exclusion of the person responsible and this without possible recourse.

Exhibitors who keep their vehicle in its outdoor location must unplug the battery from this vehicle. In the event of a disaster they will be solely responsible. They will have to be parked only on their site

The eventual cladding of walls and partitions must be made of fabrics approved M1 any other cladding is accepted only with a certificate of conformity. In particular, wallpapers, carpets not approved M3 are prohibited

The classification certificate must be presented to any inspection

**Outdoor stands:** the structures (umbrella stands, small tents, various shelters) for the outdoor exhibition must be of quality to resist the wind and, or the storm rain. They shall be suitably fastened and weighted. Their roofs shall allow water to be discharged. No flat roofs shall be tolerated.

### **Article No. 13**

Each indoor location will be equipped with a 220 volt power supply 6 Amps or a maximum power of 1200 watts. Each exhibitor will be responsible for the electrical safety of his stand and will comply with the electrical standards in force on the day of the show Large halogen headlamps must be limited in quantities so as not to exceed this power Kettles and other appliances electrical are strictly prohibited

### **Article No. 14**

The undersigned undertakes to comply with the conditions of this By-Law and all those that the association «Arts - Antiquities - Leisure» may be led to adopt subsequently. He declares to renounce all recourse against the organizing committee, his insurance and the Commune of St Méloir des Ondes in case of loss, theft or damage that could occur to his goods and materials exhibited and on himself.

### **Article No. 15**

The association "Arts Antiques et Loisirs" reserves the right to exclude an application for admission without having to give reasons for its decision and without the applicant being able to claim any compensation on this ground.

### **Article No. 16 : Jewels**

#### **ONLY FOR JEWELLERY EXHIBITORS**

- . In accordance with legislation, prices must be displayed on each item.
- . Jewellery or precious metal items must be in good standing with warranty control.
- . Each exhibitor must be able to justify their listing on the Precious Metals Register.
- . Exhibitors will be required to display on their booth a list of the most common valid marks (Gold, Silver, Platinum).

The following definitions were adopted by the organiser and the Expert:

- Antique jewelry: Jewelry made until the 1970s.
- Modern Jewelry: Jewelry made during the period 1970-1990
- Contemporary jewelry: Jewelry made after the 1990s.

Attention: only single pieces signed with high jewelry after the 1990s are allowed! As a result, any other unsigned second-hand jewellery made after the 90s will be considered new and expressly removed from sale.

**The following are prohibited on this show:**

- . Precious, fine and ornamental stones not mounted.
- . Any new jewellery – including “designer” new jewellery
- . Copies, reprints of jewellery (old, vintage, etc.), naming “in the manner of”...

\*For modern jewellery from the 70s – 90s, pieces will need to be labelled “Modern Used Jewellery” and displayed separately (in a separate display case or a specific space in the same display case).

At the request of the organizer or the expert, the exhibitor must prove their origin (purchase in auction houses; deposit or purchase to a private individual).

If modern second-hand jewellery is tolerated for sale by the organizer, its percentage must not exceed 10% of the total displayed jewellery.

**Article No 16 / 2 : Pictures and paintings**

In order to keep the name «of Antiquarians» at the fair, we accept old and modern paintings until around 1940 (oil on canvases, pastels, watercolours, drawings.) All others, later than this date, will be considered as contemporary and will be excluded.

**Article No 16 / 3 : Ivory**

Ivories must comply with the Order of 4 May 2017 amending the Order of 16 August 2016 concerning the prohibition of trade in elephant ivory and rhino horn on the national territory

**Article No 17**

As a result of the signature of their application to participate, the exhibitors declare that they are aware of the “MARCUS Decree”, Decree No. 81-255 of 3 March 1981 on transactions in works of art and objects from collections, as amended by Decree No. 2001-650 of 19 July 2001-Article 69 JORF 21 July 2001 in force on 1 October 2001. And commits to comply

**Article No 18**

Exhibitors, by signing their request to participate, grant the Organizing Committee the right to cancel or interrupt the show in the event of a major force event, notification of a decision of a public authority ordering such cancellation or interruption or the consequences of which would have that effect and in the event of the occurrence of an unforeseeable circumstance at the time of booking within the meaning of Article 1195 of the Civil Code. In the event of such cancellation or interruption, the deposit due to Arts Antiquités Loisirs will remain acquired in its entirety and the balance will be repaid by the latter in proportion to the opening time of the show and without interest. The exhibitor or the occupant of the stand will not be able to claim any damages against Arts Antiquités Loisirs, will not be able to exercise any recourse, for any reason whatsoever against Arts Antiquités Loisirs.

**Article No 19**

**The exhibitors undertake to comply with the safety instructions issued by the organizing committee as well as by the security officer who will have all powers in this regard.**

**Article No 20**

**Access Badge:**

Each exhibitor will receive a badge that he will have to wear and present to all requests of the organizers and order service during the duration of the show, for its entrances and exits from the enclosure of the show. This badge is absolutely personal and cannot be used by anyone other than the exhibitor. The loan of this badge to any other person will result in the outright exclusion of the exhibitor

**Article No 21**

**Right to the image**

By simply registering for this show, the exhibitors give the organizing association the right to the image of its stand, of itself and of its collaborators. These photos may be used by the organization for promotional and advertising purposes for the antique fair

**Article No 22**

By registering as a participant in the Salon des Antiquaires de St Méloir des Ondes, the present rules are accepted without any possible derogation or recourse.

In the event of disputes, the court at the headquarters of the organisation (St Malo) shall have sole jurisdiction, the French text of this Regulation being authentic.

**Article No 23**

The locations stipulated on our website [www.salon-antiquaires.fr](http://www.salon-antiquaires.fr) are for information purposes only. They can be modified according to the needs of the organization. They will not be final until July 25. Exhibitors registered after this date will not be able to be included, nor will they be included on the brochure given to visitors
